

No. AHE. 425/2006/98: The Governor of Assam is pleased to take over the Kokrajhar College, Kokrajhar as a Govt. College subject to the following terms and conditions with immediate effect and rename the said college as Kokrajhar Government College, Kokrajhar.

TERMS AND CONDITION:

- A) The Govt. of Assam takes over the existing movable and immovable assets of Kokrajhar College on the basis of "as is where is basis "(break up shown at Annexure-I),
- B) The Govt. of Assam will bear financial liability in regard to only 83 (eighty three) sanctioned posts with immediate effect. (break up of which is enclosed as Annexure -II).
- C) The Principals followed in the case of Haflong College. Haflong in 1975 regarding creation of posts, regularisation, seniority and other service conditions will be applicable to the staff (teaching and non teaching) working against sanctioned posts in Kokrajhar College also.
- D) Since the Non sanctioned (teaching and non teaching posts do not have approval of the State Government, the Government will not take over the financial liabilities relating to the salaries/wages of personnel working against these non sanctioned posts.
- E) The other terms and conditions will be at par with that of other Govt. Govt. colleges followed in this regard.
