**NOTICE**

**(Regarding the Abhinanda Education Loan Subsidy Scheme 2.0)**

In pursuance of the letter from the Director of Higher Education, Assam, vide ref no. FM.460891/15, dated: 02-09-2024, it is hereby informed to all students of Kokrajhar Govt. College that the Govt. of Assam, Finance (A&F) Department has implemented the "Abhinandan" Education Loan Subsidy Scheme 2.0 for pursuing Higher Education by children of Permanent Residents of Assam.

The Govt. of Assam will deposit upto ₹50,000/- (Rupees Fifty Thousand Only) or the outstanding amount in the eligible Education Loan account, sanctioned between 1<sup>st</sup> April, 2020 to 31<sup>st</sup> March, 2024, as a one-time support to the students for pursuing higher education. If a loanee has already closed the loan account by repayment, he/she will not be entitled for the benefit under the scheme.

Therefore, eligible students of the college who are permanent residents within the state of Assam may avail this Education Loan for higher studies.

**Eligibility Criteria:**

1. The Scheme will cover all students who are permanent residents of Assam, pursuing higher education in the state or outside and have availed education loan from Scheduled Commercial Banks, Regional Rural Banks and the Assam Cooperative Apex Bank, as notified by RBI.
2. The Scheme shall be admissible on a specified application by the intending student through online portal.
3. Children of sitting Public Representative – Member of Parliament/Member of legislative Assembly, Panchayat functionaries, permanent employees in the Government/Government PSU will not be eligible for the scheme.
4. The minimum education loan amount sanctioned to avail the benefits under the scheme shall be ₹2 Lakh.
5. Any Loan account, which has been classified as Non-Performing Asset by the banks under Reserve Bank of India norms, will not be eligible under the scheme.
6. The benefit under this scheme can be availed just once by the beneficiary.
